Please enter the above named child in Montessori Children's House for the 2010-2011 school year starting September 2010. In consideration of the school's acceptance hereof, (I), (we) agree that the terms of the child's enrollment shall be the following:

1. Definition: The word "parent" means parent or parents or guardian or guardians. The word school means Montessori Children's House.
2. Payments: Registration Fee: \$150 for new students and is non-refundable and non-applicable.

Tuition is:

5 Day Program -- AM \$278.00 / 10 months PM \$240.00 / 10 months
(Tuition payments are made August through May – School begins in September)
Extended Day Program in Montessori Classroom – 11:30 – 2:45p.m.
1 day \$60; 2 days \$115; 3 days \$165; 4 days \$210; 5 days \$250 per month
Before and After School Care \$5.00 per hour

Payment Options:

- A. Full payment due August 1, 2010
- B. Two payment plan: 60% due August 1, 2010
40% due February 1, 2010
- B. 10 monthly installments; first installment due August 5, 2010
\$10.00 processing fee for automatic monthly payments (one time fee)
Tuition payments shall be the total annual tuition divided by ten (10) and will be
Paid monthly beginning August 5, 2010.
Automatic Tuition payments will be processed on the 5th or the 10th of each month

Before and after school hours will be billed on the 5th of the month for the previous month.

3. The non-refundable registration fee must accompany the application for enrollment along with the signed registration contract for 2010-2011.
4. The first 30 days of school is on an evaluation period for all new children enrolled at the Montessori Children's House. The school reserves the right to dismiss any student if in the school's judgment the family is not cooperative or if the student is not suited to the program.
5. Written notice must be given at least 30 school days before withdrawal of a child from Montessori Children's House. In the event that a withdrawal is made without such notice, the parent shall assume financial responsibility for the payment of one full month of tuition. If a child is withdrawn after April 1, the parent shall assume financial responsibility for each of the monthly tuition payments due through the end of that school year.

6. Students will not be accepted into school if tuition is 30 days late. Students will be able to return to school when tuition is brought up to date.
7. There will be a \$25 service charge for any check or processed payment returned because of insufficient funds.
8. This is an enforceable contract, voluntarily entered into between (me) (us) and Montessori Children's House and by registering this student. Montessori Children's House is relying upon (me) (us) to pay all expenses as agreed herein. In the event that (I) (we) do not make such payments and the account is turned over for collection, (I) (we) agree to pay all cost of collections, including all reasonable attorney fees, plus court costs and/or collection agency fees, together with interest thereon at the maximum amount allowed by law.
9. Any balance not paid and over 30 days past due will be charged a \$25 late fee.
10. Volunteer Hours: In keeping with the purpose and the spirit of the Montessori approach to education, Montessori Children's House strongly encourages the parents to become involved in the activities of the school. This positive participation includes communication between teachers and parents as well as parent's agreement to voluntarily provide 5 hours of service to the school each school year. Parents are reminded that through their volunteer participation the child sees and understands that the parent sincerely and deeply cares about the student and the school and a sense of value and pride is fostered
11. Fundraisers: All parents are to be involved in fundraising at the Montessori Children's House. We have a fall and spring fundraiser and the end of the year program/dinner/auktion. The goal amount for the fundraisers will be announced and each family will be expected to bring in a minimum amount or make up the difference. If you do not want to participate in the fundraisers you may opt to buy out for \$75. The end of the year event is our biggest fundraiser and we ask that everyone participate.
